**Ice Rental Terms and Conditions for the William H. Bill Bolton Arena on reverse.**

The Licensor Agrees:

1. To hold the ice time set out for the exclusive use of the Licensee each week and to permit the Licensee access to the ice surface as close to the time(s) allotted as possible.
2. To provide adequate lighting of the ice surface and use of goals nets (no goal posts) and such dressing rooms as are reasonably required.
3. To notify the licensee as soon as practicable should the Arena for any reason whatsoever be closed so as to prevent the use of the ice surface or other Arena facilities by the Licensee at the time(s) agreed.

The Licensee Agrees:

1. To make use of the ice surface and Arena facilities on the days and at the times agreed.
2. To pay the rental fee at or before each time period.
3. To notify the Licensor not less than two weeks in advance should the Licensee be unable to make use of the allotted times.
4. To abide by and cause Licensee's members to abide by the regulations set out below, all of which form part of the contract.
5. The licensor will not be responsible for any bodily injury or death of, or loss or damage to any property (including, without limitation, money, equipment, personal property and clothing) belonging to the Licensee's members arising from or occasioned by any act or omission whatsoever, including negligence, theft or malfeasance, on the part of the Licensor or Licensor's members or otherwise.
6. To indemnify the licensor and Licensor's members with respect to all suits, actions, claims, damages, costs or prosecutions to which the Licensor or any of the Licensor's members may incur or become liable by reason of the use of the Arena by the Licensee's members.

#### REGULATIONS

1. A deposit equal in amount to one time period rental shall be paid by the Licensor when the Contract is signed and delivered by the Licensee. The deposit will be held by the Licensor and applied against the last rental of the season. If any payment is not made when due or if any damage is caused by Licensee or Licensee's Members, the Licensor shall be entitled to apply the deposit towards such overdue payment or towards the cost of repairs, as the case may be, in which event the Licensee shall replenish the deposit before the next rental period.
2. Acceptable methods of payment are cheque, credit card, debit card and cash. Post-dated cheques and monthly credit card payments will be processed at the beginning of each month.
3. Rental fees at the hourly rate provided will be charged if the Licensee fails to notify the Licensor not less than two weeks in advance of Licensee's inability to make use of the time allotted.
4. The Licensee shall be responsible for payment of the rental fee.
5. All teams must vacate the dressing rooms not later than 30 minutes from the time the teams leave the ice surface.
6. The Licensee shall be responsible for and shall compensate the Licensor for any damage to the Arena or equipment by any Licensee's Members during the practice sessions or games and while Licensee's Members are occupying or using the Arena.
7. Consumption of alcoholic beverages and Smoking in or near the Arena is strictly prohibited.
8. No food or beverages (other than those purchased at the Snack Bar) may be brought into or consumed in the Arena, unless otherwise expressly permitted by the Arena Manager.
9. All scraping and/or flood of the ice surface will be taken out of the time(s) allotted to the Licensee, approximately 10 minutes.
10. The Licensee shall keep players off the ice surface until the Zamboni leaves the ice and the end doors are closed. Similarly, Licensee shall require all players to leave the ice surface promptly when the Zamboni horn is sounded indicating that the Licensee's time has expired.
11. Failure by the Licensee to abide by any of the provisions of the Contract or of the above regulations shall entitle the Licensor to cancel the contract without notice.
